# Major Projects and Results at Illinois

- IT@Illinois. IT@Illinois was a campus-wide effort to reshape IT support around the changing needs of 21st Century research and education. Its primary goal was to rethink support to adapt to work that is increasingly interdisciplinary, interinstitutional, and international. Highly tuned to NSF objectives for connecting researchers and resources, IT@Illinois was aimed at "advancing research, education, and public service by making every potential contributor the center of an unbounded personal network of social and technical resources." Priorities included not only high performance computing and advanced networking, but new management innovations such as campus cyberinfrastructure master planning, cyberinfrastructure impact analysis, and new support roles specializing in social network connections. The core ideas for IT@Illinois are woven through A Research Cyberinfrastructure for the CIC: Advice to the Provosts from the Chief Information Officers (http://www.cic.net/CyberInfrastructurePaper).
- Cost Containment and Resource Use. Unlike many other efforts to reduce university spending on IT, IT@Illinois began with the premise that the fastest path to lasting cost containment is not tweaking the legacy environment, but transforming the support environment entirely around the logic of future needs. Beginning with a coherent view of 21<sup>st</sup> Century support needs of faculty and students, re-examination of the support environment exposed many areas where costs accumulate around badly adapted service. IT@Illinois and associated work in the Stewarding Excellence initiative identified service improvements that will yield recurring savings to the campus in excess of \$10M annually, while using productivity gains to as a resource base for new initiatives. - **Social Network Focus.** Everything connected with IT@Illinois required equal participation from CITES (which reports to the CIO) and from IT professionals employed elsewhere on campus (reporting to Deans or other unit heads). This has meant reorganizing CITES to operate with greater autonomy under an Executive Director and mobilizing the rest of the IT professional community into a cohesive informal network of colleagues. - *Community Big Broadband.* Based on a proposal to NTIA developed within CITES, the University of Illinois was awarded \$22.5 Million in federal funds and an additional \$3.5 Million in state matching funds to create an optical fiber infrastructure extending

throughout Champaign and Urbana. This project has many novel technical and organizational features, including a provision for 100 Mbps symmetric connections to about 2500 lower-income homes.
